CFK must compare the information on your FAFSA to either the <u>2018 IRS Tax Return</u> <u>Transcripts OR the SIGNED copy of the 2018 tax return and all schedules</u> and/or with W-2 forms and/or other financial aid documents. If there are differences between your application information and your financial documents, your FAFSA may be corrected. Also, we may request additional information. You / Your Spouse must sign and complete the worksheet, attach any required documents, and submit to the Financial Aid Office.
