Florida Classroom Teacher Tuition Registration and Fees Exemption Request

FS 1009.26(10)

A state university or Florida College System institution may waive tuition and fees for a classroom teacher, as defined in s. 1009.26(10) who is employed full-time by a school district and who meets the academic requirements established by the Florida College System institution or state university. The State Board of Education shall adopt a rule that prescribes the process for the approval of courses by the department.

Fees Waived: Tuition, registration fees, and laboratory fees for up to 6 credit hours per term.

Eligibility Terms:

- Student must obtain the "Florida Classroom Teacher Tuition and Fees Exemption Form".
- Student must complete all admissions requirements, including the Application for Admission, placement testing, transcripts, etc. prior to registering for class(es).
- Registration is for up to 6 credit hours per term for undergraduate courses approved by the Department of
 Education on a space-available basis only and cannot occur prior to the last day of the drop period (no
 deferments, no reimbursements) for the semester the student is enrolling in. Such courses shall be limited
 to undergraduate courses related to special education, mathematics, or science.
- The exemption may not be used for courses scheduled during the school district's regular school day.
- The Classroom Teacher must receive approval from their school's Principal.

Conditions:

- Tuition will be exempt for a maximum of six (6) credits, (lab fees are not covered). The exemption is for
 college credit courses including post-secondary adult vocational courses (vocational credit); it does not
 apply to non-credit (continuing education) courses or adult education courses. Courses to which the fee
 exempted is to be applied must be indicated on the waiver form.
- Courses must be taken for a grade; they may not be taken as audits.
- Florida Classroom Teacher Tuition Registration Fee Exemption Application and form verification must be
 assessed each term. If verification is not confirmed, the student will be responsible for tuition and fees.
 Failure to do so will result in fees being assessed.
- The State employee must pay any fees not covered by the fee exemption.
- Receiving this exemption does not constitute classification as a Florida resident for tuition purposes and does not necessarily qualify you for such classification in the future.
- You must apply for this exemption every term before the posted residency documentation deadline at the Office of Enrollment Management, Admissions. Failure to do so will result in fees being assessed.
