DISABLED VETERANS TUITION AND FEE WAIVER APPLICATION

Pursuant to s. 295.011, F.S., beginning with the 2022-2023 academic year, a disabled veteran enrolled in a program of education approved for educational assistance under 38 U.S.C. s. 3313, and pursuant to the eligibility outlined in 38 U.S.C. s. 3313(2), as one who serves at least 30 continuous days on active duty in the Armed Forces commencing on or after September 11, 2001, and after completion of service, is discharged or released from active duty in the Armed Forces for a service-connected disability. A disabled veteran who does not qualify for the 100-percent eligibility tier under federal law is eligible to receive a waiver for tuition and fees. Therefore, eligible recipients of the waiver are disabled veterans classified by any military branch as 100 percent disabled, but do not qualify to receive 100 percent in GI Bill educational benefits.

To be eligible for this out-of-state fee waiver, veterans will be expected to provide the following documentation:

- Service and Separation proof: DD-214, Retirement or separation orders, or an official statement from the military personnel records center.
- Compensable Service-Connected Disability proof: An official document from the Department of Veterans Affairs or an Armed Forces branch certifying the 100 percent total and permanent service-connected disability rating or An official document or retired orders from an Armed Forces branch showing that the veteran was retired due to a service-connected disability or has been transferred to a Disability Retirement List with a 100 percent total and permanent service-connected disability rating.
- Portion of Tuition and Fees Paid in Accordance with Federal Law proof: A Veteran Affairs Award Letter showing a 100 percent total and permanent service-connected disability rating and the portion of tuition and fees paid in accordance with federal law or an official document from the Department of Veterans Affairs showing the portion of tuition and fees paid in accordance with federal law.

By signing this form, I (the student whose name and information appears on this application) understand and agree to the following terms:

- a) Receiving this out-of-state tuition waiver does **NOT** constitute classification as a Florida resident for tuition purposes and does **NOT** necessarily qualify me for such classification in the future.
- b) I must reapply for this waiver if I break enrollment for a year or more.
