

FLORIDA STUDENT HOMELESSNESS VERIFICATION FOR TUITION AND FEE EXEMPTION PURPOSES

Pursuant to Section <u>1009.25(1)(e)</u>, Florida Statutes (F.S.), each Florida College System institution's board of trustees, each district school board with a career center authorized under Section <u>1001.44</u>, F.S., and each board of directors for a charter technical career center authorized under Section <u>1002.34</u>, F.S., shall adopt and implement policies or procedures to ensure the exemption of tuition and fees for eligible students experiencing homelessness while enrolled.

Section 1 shall be completed for certifying students under Section 725 McKinney-Vento Homeless Assistance

Act eligibility. Section 2 shall be completed for students eligible under section 11302(a)(1) of the McKinneyVento Homeless Assistance Act or pursuant to standards under United States Code (U.S.C.) section 1087uu-2a.

All authorized personnel must complete either Section 1 or Section 2 (not both), and Section 3.

Any student who is determined to be a student experiencing homeless for a preceding award year is presumed to be homeless for each subsequent year unless the student informs the institution their circumstances have changed or the institution has specific conflicting information about the student's independence and has informed the student of this information.

Pursuant to Rule 6A-10.087, Florida Administrative Code (F.A.C.), institutions may request additional documentation if the student reenrolls after discontinuing enrollment for 12 consecutive months or more.
